# DEFENCE & SECURITY

Rethinking National Security Post-Pandemic by Ambassador Vice Admiral (R) Khan Hasham bin Saddique, President IPRI

Although Pakistan was envisioned to be a welfare state, geopolitical and regional dynamics necessitated prioritization of national security over human security. The attainment of nuclear deterrence ushered in strategic balance, which ensured that war with India remained at bay. The COVID-19 situation thrust upon us divinely, is yet another defining moment in our history that compels policymakers to chalk up a national strategy, leveraging the strengths of all the elements of the national power potential in a post-pandemic world of new possibilities. Pakistan's national security plan must acknowledge that, firstly, national security must include human security. Secondly, the outcome of future wars depends on overall power, not military might. Thirdly, a "Cross Domain deterrence strategy" must be devised.

Cessation of hostilities is imperative, as escalation of longstanding conflicts pose as a hindrance in the global fight against COVID-19 pandemic. Conflict zones in South Asia, the Middle East and North Africa are home to vulnerable populations, with poverty, dilapidated health infrastructures and limited financial resources rendering them incapable of dealing with the pandemic. Escalation of violence will leave the vulnerable populations at a heightened risk. Thus, ceasefires, across all regions and parties to the conflict, are a necessity for curbing the pandemic.

Nightmare of Globalization: Will Corona Reverse Globalization? by **Waleed Yawer**, Assistant Research Officer

Trade and tourism, the fundamentals of globalization, are threatened by the ease of

transmission, and not the potency, of Coronavirus. The crisis is far beyond the economic perils banks were insulating themselves from. A chain of uncertain and uncoordinated reactions, fuelled by ambiguity and market mania ensue, including disruptions to the stock market, slashing of interest rates, blocking of human and service mobility, all leading to curtailment of global revenue streams. A fiscal and socio-political consensus-driven and structured strategy must be devised to orchestrate a response to the uncertainty that arises from the pandemic, especially targeted at vulnerable regions.

Washington's smear campaign against Beijing's COVID-19 efforts remains active amid Trump administration's own governance crisis which has contributed to a rapid escalation in infections. To discredit China's globally acclaimed containment efforts, it accuses Beijing, without evidence, of under-reporting casualties. Unlike the US, China has integrated asymptomatic cases into national count to boost transparency. By directing criticism towards Beijing, Washington is only masking its governance gaps.

As the waning global leadership of the US is juxtaposed with that of rising powers such as China, the question arises as to who will dominate the post-pandemic era. From a position of global domination of the US for most of the past century, now an effective US response to the COVID outbreak is inconspicuous not only globally, but also within its own borders. China's global recognition for its unprecedented public health response has led some to claim that it will now emerge as the global leader.

Political Deadlock Compounds Iraq's COVID-19 Fight by **Hannan Hussain**, Assistant Research Officer

Amid the COVID-19 pandemic, a new Prime Minister designate of Iraq, the former intelligence Chief, Mustafa al-Kadhimi, has been nominated with decisive Shiite political support. This comes at a time when the window to contain COVID-19 in the Middle East is narrowing, and only a handful of countries in the region are capable of using nationwide shutdowns to public benefit. Though he has high chances of forming a new cabinet within the 30-day deadline, the longer it takes to form a government, the greater the setback for containment efforts.

The Government of Pakistan's limited ability to deal with the COVID-19 crisis highlights its skewed spending priorities, where the health sector gets a meagre share in the national budget. Given that pandemics are fought with national resolution and resources, Pakistan is caught highly unprepared. The core reason is that Pakistan's political economy is heavily tilted towards substantial elite capture of state resources, at the expense of neglected sectors ministering to human security.

Cheapskates & Bringing Home the Bacon by Adeel Mukhtar Mirza, Assistant Research Officer

The pandemic is causing dire financial consequences for economies and businesses around the world. It is imperative for governments to devise strategies to limit financial losses and secure the vulnerable segments of society. With lockdowns in place in Pakistan, between 12.3-18.5 million individuals are estimated to be rendered unemployed, resulting in monetary ramifications for labourers that will drive them to destitution. Furthermore, the absence of secure work contracts, legitimate assurances, and proper implementation of work regulations could aggravate the crisis. To counterbalance the monetary hardship, the government should, to the greatest extent allowed by its assets, help low-wage labourers and take action against exploitative factory owners.

Reservations over Debt Issuance, Fiscal Conservatism Unwarranted as the EU Seals COVID-19 by Hamzah Rifaat Hussain, Assistant Research Officer

The 3.2 trillion Euros Coronavirus package is a fiscal response by the EU to the pandemic, a deal whose deliberation was initially marred by a complete absence of solidarity by some member states. The resultant gap was filled by prompt support from two non-EU countries, China and Russia. The 2010 debt crisis, existence of a fiscally conservative North and an indebted South make member states wary of sharing debt financing, and ultimately lead to the perceived inability of the EU to combat emergencies.

Avalanche of COVID-19 on Indian Health Care System by Adeel Mukhtar Mirza, Assistant Research Officer

Given its inept health care sector, India is struggling to tackle the spread of COVID-19 in its 1.3 billion inhabitants, exposing that Indian expertise in health sector and affordability was widely exaggerated in Prime Minister Modi's narrative of "Shining India". The ground reality is alarming: only 0.7 beds per 1,000 occupants, testing shortages and limited test facilities. Shortage of disinfectants and costly protective masks render these items inaccessible to most. Given the limits of Indian public healthcare system to manage the crisis, private health care and private pharmaceutical companies have stepped in to fill the gap, leaving the poor facing high costs for treatment.

In the battle against COVID-19, national governments are engaging citizens to take measures to assist those in need. Along with measures, such as grant of a PKR 1.13 trillion relief package, Pakistan has also set up the Corona Tigers Relief Force. This nationwide volunteer youth force is tasked to deliver food and medical supplies and raise awareness about the ongoing crisis. The Tiger Force is envisioned to utilise the large youth population in the country and also help avoid proliferation of the virus.

The closure of educational institutions, due to the lockdown, poses as an opportunity for institutes to implement effective solutions to overcome challenges of online learning. Classroom; ensuring availability of essential private space to students and teachers for completion of pending academic commitments; and providing psychological support to students dealing with seclusion.
