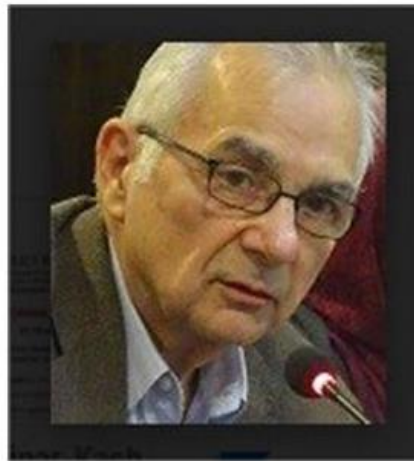

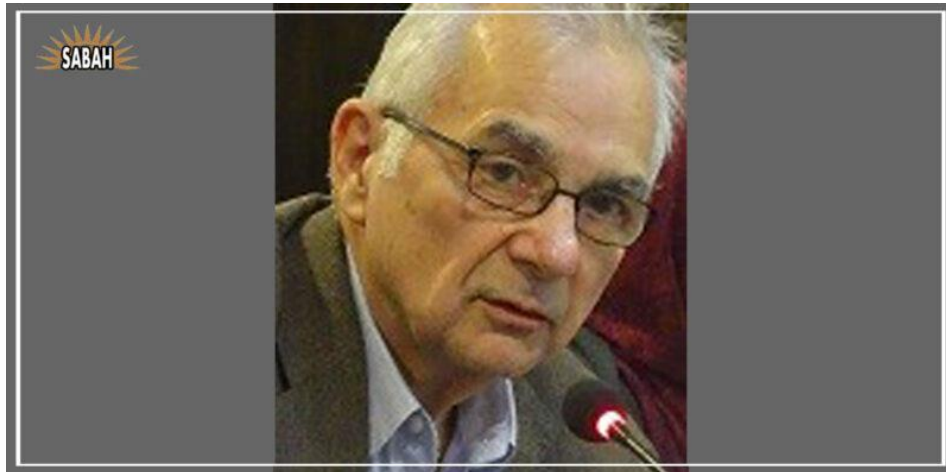

If that happens, India will, sooner or later, have to accept the reality that it can neither permanently crush the Kashmir liberation struggle nor successfully blame Pakistan for its inability to do so. Pakistan must develop options and take risks to ensure freedom and justice for Kashmir and to chart a course for peaceful coexistence with India.

and Kashmir (IOJK): International Response to the Clampdown” organized by the Islamabad Policy Research Institute.

Discussing the recent US Commission on International Religious Freedom report that designated India as a “country of particular concern” over its maltreatment of religious minorities mainly by “non-state actors”, Ambassador Qazi said that even Genocide Watch has issued a Genocide Alert for India Occupied Kashmir and called upon the United Nations and its members to warn India not to commit genocide in the territory.
